Missouri State University Head Coach Keith Guttin, and Assistant Coach Matt Lawson will be instructors for MSU's Winter Hitting Camps. The camps will be held at **Hammons Field, Bill Rowe Training Facility** (955 E. Trafficway). Session 1 will be held Jan. 11-12, and Session 2 will take place Jan. 18-19. Both sessions will run from 8:00 a.m. until 12:00 p.m. Enrollment is limited, so please enroll early.

Keith Guttin

Keith Guttin enters his 38th season with MSU as the winningest coach in MSU history. Under Guttin's leadership, the Bears have made 11 NCAA Tournament appearances, including a 2003 College World Series berth, as well as Super Regional appearances in 2015 and 2017. During his tenure, 125 MSU players have signed professional contracts and 19 have advanced to the major leagues.

Matt Lawson

Matt Lawson begins his third season as MSU's hitting coach, infield coach and recruiting coordinator. Lawson previously served as a student assistant coach and graduate manager for the Bears upon completing his own seven-year professional playing career. Lawson played collegiately at MSU from 2005-07, before being drafted in the 14th round of the 2007 MLB Draft by the Texas Rangers.
